### **January 30, 2024**

President Steven Perik, Jr., brought the meeting to order at 6:36 P.M. Present were Board members Scott Klein, Rick Bartel, Todd Persha, Eric Schuette, Dean Bennett, Brandon Gentz, Debbie Priebe and Kris Pecha.

#### **President's Report:**

**Rick Bartel** – Is concerned that not having had a race in December could negatively impact our race season.

**Kris Pecha** – Went to the IOU race in Dorchester to experience first-hand how they run their events and to promote PVR to the racers at that event. The track was soft, water came up through the ice as the day went on. There were too many accidents happening, so they called the event about halfway through.
